Most of us had also seen a movie based on the book starring Anthony Hopkins as the butler, Stevens. Since we all liked the book, there was little controversy. We also agreed that Anthony Hopkins was the perfect choice to play Mr. Stevens in the movie, which is available on YouTube,

Our January book will be What We Can Know by Ian McKewen. This is the latest book by the author of Atonement. It is set 100 years in the future in a world where most of the land has been submerged due to a nuclear accident. There are flashbacks to the 21st century that are tied into the search for a poem from that period that has been lost. In his search for the poem, the researcher uncovers previously unknown information about the poet and others in his world.

For February we selected 84, Charing Cross Road by Helene Hanff. It is a true story taken from the author's life and is in the form of an exchange of letters between the two main characters. There is also an Anthony Hopkins movie based on this book, which some of us may watch to compare his character in that story with the one that he played in Remains of the Day
